## Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH)

Intertek provides the following REACH-related services for restricted substances in articles:

- Regulatory training (onsite/webinar): Training and education on REACH requirements.
- Ad hoc consulting: Information on how articles are regulated under REACH, how to ensure compliance with REACH, and how to develop a compliance strategy.
- Product requirements analysis: Analysis of the product requirements under REACH.

- Testing strategy support: Support for, and determination of, appropriate testing strategy.

- Notifications for articles (REACH IT): Submission of notifications to the European Chemicals Agency (ECHA) in cases where substances of very high concern (SVHCs) have been identified.
- Reporting: Support in writing reports declaring the absence of REACH SVHCs and substances listed in REACH Annex XVII and Annex XIV.

## Restriction of Hazardous Substances (RoHS)

Intertek provides support for:

- European Union (EU) RoHS;
- Saudi Arabia RoHS (IECEE Certificate Registration);
- United Arab Emirates RoHS; and
- Other RoHS regulations worldwide.

Specifically, Intertek provides the following RoHS-related services:

- Regulatory training (onsite/webinar): Training on the requirements of RoHS regulations worldwide.

- Material/supplier risk assessment: Risk assessments and risk mitigation strategies for the customer's BoM (Note: Each article can be justified as low risk either through the composition of the component/material, documentation collected for the specific components/materials, or through risk mitigation strategies).
- Restricted Substances Control (RSC) program: One-day onsite workshop to educate customers on the restricted substance requirements and train them on how to implement an internal RSC program (Note: If a customer is 9001/14001 registered, Intertek can assist with utilizing those processes for creating a RSC program specific for RoHS and other global requirements).
- Reconciliation: Liaising with the required authorities for reconciliation and prepare the required technical documentation and mitigation actions when a product has mistakenly been placed on the market.
- Certificate & registration: Registration of products with the applicable country authorities and issuance of the certification.

## Waste from Electrical and Electronic Equipment (WEEE)
